Yakuba igqibile, iIRMA iza kukhupha ingxelo ebhaliweyo eya kuMasipala wengingqi nezakufumaneka nangonxibelelwano lwe internet. Le ngxelo iza kuchaza indlela iERM CVS enike ngayo iSibanye-Stillwater Rustenburg amanqaku kumqathango ngamnye kweyi 400 nangaphezulu ye-IRMA Standard for Responsible Mining, ichaze ngokunjalo ukuba ifikelele njani kuloo manqaku iwanike iSibanye-Stillwater Rustenburg. Kananjalo le ngxelo iza kucacisa ngempumelelo ngokuphathelele kuzo zonke izigaba: IRMA Transparency, IRMA 50, IRMA 75, or IRMA 100.

iSibanye- Stillwater ingalusebenzisa olulwazi ilufumeneyo ngemeko yobume bendalo nobentlalo ukuphucula indlela abasebenza ngayo. Kananjalo nabanye abachaphazelekayo ngakumbi abahlali, banokulusebenzisa olu lwazi luqulethwe yile ngxelo ekubonisaneni nasekuxoxeni neSibanye-Stillwater nezinye iinkampani ukuphucula indlela abasebenza ngayo, bethetha beqondana.
